

## **Official Facebook Summer Hits Sweepstakes Rules & Regulations**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OF DOES NOT INCREASE THE CHANCES OF WINNING.**

These are the official rules that govern the operation of the Summer Hits Sweepstakes (the “Sweepstakes”) taking place from July 11- July 27, 2018. This Sweepstakes is sponsored by Kids Quest, Inc. (“Sponsor”) and is no way sponsored, endorsed or administered by, or associated with Facebook, Twitter, Pinterest or Instagram. **Void where prohibited by law or where prior registration or approval is required, including, but not limited to, Arizona, Puerto Rico and other US territories or possessions.**

**3. Sweepstakes Period:** Entries will be accepted online starting Friday, July 11, 2018 at 12:00AM CST and ending Wednesday, July 25, 2018 at 11:59PM CST.

**4. How to Enter:** The Sweepstakes must be entered by submitting an entry using the online form provided at <https://woobox.com/wctcda>

- a. The entry must be fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Kids Quest.
- b. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices to circumvent the rules.
