Official #Love, Cyber Quest Contest Rules & Regulations

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

These are the official rules that govern the operation of the Love, Cyber Quest Instagram Contest taking place February 1-28, 2019. This Contest is sponsored by Kids Quest, Inc. ("Sponsor") and is no way sponsored, endorsed or administered by, or associated with Facebook, Twitter, Pinterest or Instagram. **Void where prohibited by law or where prior registration or approval is required, including, but not limited to, Arizona, Puerto Rico and other US territories or possessions.**

4. **How to Enter:** The Contest must be entered by submitting an entry via Instagram and tagging handle @kidsquestinc and using hashtag #lovecyberquest or #whyilovecq
 - a. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Kids Quest.
