These are the official rules that govern the operation of the Show Us Your Spin Instagram Contest taking place June 16 - 29, 2019. This Contest is sponsored by Kids Quest, Inc. ("Sponsor") and is no way sponsored, endorsed or administered by, or associated with Facebook, Twitter, Pinterest or Instagram. **Void where prohibited by law or where prior registration or approval is required, including, but not limited to, Arizona, Puerto Rico and other US territories or possessions.**

3. **Sweepstakes Period:** Entries will be accepted online starting Sunday, June 16, 2019, at 12:00AM CST and ending Saturday, June 29, 2019 at 11:59PM CST.

4. **How to Enter:** The Contest must be entered by submitting an entry via Instagram and tagging handle @kidsquestinc and using hashtag #SpinIntoSummer2019

Please note that your account must be set as public for Kids Quest, Inc. to receive your submission.

- a. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Kids Quest.
