



RULES AND REGULATIONS

Kids, Critters, and Glitter Holiday Photo Contest

These are the official rules that govern the operation of the Kids, Critters, and Glitter Social Media Contest taking place November 29 - December 31, 2019. This Contest is sponsored by Kids Quest, Inc. ("Sponsor") and is no way sponsored, endorsed or administered by, or associated with Facebook, Instagram, or Twitter.

 - f. You are not an immediate family (parent, sibling, spouse, child) or household member of:
 - i. An employee of Sponsor or a Sponsor parent, subsidiary or group company; or
 - ii. A person involved in any part of the administration and execution of this Contest.

4. **How to Enter:** The Contest must be entered by submitting an entry via Instagram and using the hashtag #KCG19

The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Kids Quest.

- a. You may enter as often as you like, but you must provide the information requested. If you use fraudulent methods, fraudulent information, or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Kids Quest, Inc.

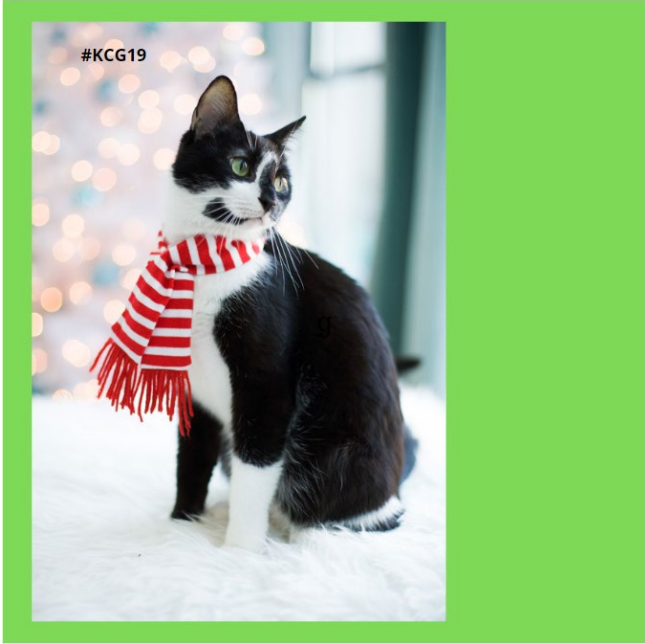
