RAFFLE RULES

Official Backstage Pass Raffle Rules & Regulations

These are the official rules that govern the operation of the Backstage Pass Raffle taking place August 1-30, 2022. This Raffle is sponsored by Kids Quest, Inc. ("Sponsor").
