RAFFLE RULES

Official Summer Throwback Raffle Rules & Regulations

These are the official rules that govern the operation of the Summer Throwback Stamp Card Raffle taking place June 1 - July 31, 2023. This Raffle is sponsored by Kids Quest, Inc.
