



## RAFFLE RULES

### Official Summer Throwback Raffle Rules & Regulations

These are the official rules that govern the operation of the Summer Throwback Stamp Card Raffle taking place June 1 - July 31, 2023. This Raffle is sponsored by Kids Quest, Inc. ("Sponsor"). **Void where prohibited by law or where prior registration or approval is required, including, but not limited to, Puerto Rico and other US territories or possessions.**

1. **Eligibility:** This Raffle is open to individuals who meet all of the following criteria:
  - a. By entering a submission in the Summer Throwback Stamp Card Raffle, you affirm that you are at least 18 years of age, or an emancipated minor, or possess legal parental or guardian consent to participate in this Raffle and that you are fully able and competent to enter into terms, conditions, obligations, affirmations, representations and warranties set forth in these official rules.
  - b. You confirm that your Summer Throwback submission is your own and all associated requirements were not performed by anyone else.
  - c. You are not an employee of Sponsor or any Sponsor parent, subsidiary or group company;
  - d. You are not involved in any part of the administration and execution of this Raffle.
  - e. You are not an immediate family (parent, sibling, spouse, child) or household member of:
    - i. An employee of Sponsor or a Sponsor parent, subsidiary or group company; or
    - ii. A person involved in any part of the administration and execution of this Raffle.
  - f. Each Entrant will be responsible for ensuring that their participation in, and entry into, this Raffle is valid and in compliance with their relevant local law. This Raffle is void where prohibited by law and where prior registration or approval is required including, but not limited to, Puerto Rico and other US territories or possessions.
  
2. **Agreement to Rules:** By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, you agree to accept the decision of Kids Quest, Inc. as final and binding as it relates to the content and winners of this Raffle.
  
3. **Raffle Period:** Entries will be accepted in center starting Saturday, June 3, 2023, two hours after center's opening (local time) and ending Monday, July 31, 2023 at center's closing (local time).
  
4. **How to Enter:** The Raffle is entered by completing all the required tasks. Six stamps for daily visits at Kids Quest of 2 or more hours, the purchase of Daily Quest Bonuses at Cyber Quest, or a combination of the two.
  - a. The entry must fulfill all Raffle requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Kids Quest.
  - b. You may enter as often as you like, but you must provide the information requested. If you use fraudulent methods, fraudulent information, or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Kids Quest, Inc.
  - c. Guests may receive one stamp per day per business (Kids Quest and Cyber Quest) and may only work towards the completion of one card at a time.



## RAFFLE RULES

5. **Prizes:** The Winner of the Summer Throwback Stamp Card Raffle will receive:
  - a. Three Grand Prize winners of a Nintendo Switch OLED Console (\$349.99 value)
    - i. The specifics of the prize shall be solely determined by Kids Quest, Inc. No cash or other prize substitution shall be permitted except at the discretion of Kids Quest, Inc.
    - ii. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winner is permitted. Acceptance of prize constitutes permission for Kids Quest, Inc. to use winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
  
6. **Odds:** The odds of winning depend on the number of eligible entries received.
  
7. **Winner Selection and Notification:** Winners will be selected by random drawing upon completion of the Raffle on Tuesday, August 1, 2023. Winners will be notified by email by Wednesday, August 2, 2023. Kids Quest shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information.
  - a. If Winner cannot be contacted, is ineligible, fails to claim the prize within 5 business days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited, and an alternate Winner selected. Receipt by Winner of the prize offered in this Raffle is conditioned upon compliance with any and all federal, state, and local laws and regulations.
  - b. ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER (at Kids Quest's sole discretion) WILL RESULT IN WINNER'S DISQUALIFICATION AS WINNER OF THE RAFFLE AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.
  
8. **Rights Granted by You:** By entering this Raffle, You understand and agree that Kids Quest, anyone acting on behalf of Kids Quest and Kids Quest licensees, partners, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the World, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the Raffle, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes, without any further compensation, notice, review, or consent.
  
9. **Terms & Conditions:** Kids Quest reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Raffle should a virus, bug, non-authorized human intervention, fraud, or other cause beyond Kids Quest control corrupt or affect the administration, security, fairness, or proper conduct of the Raffle. In such case, Kids Quest may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Kids Quest. Kids Quest reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts tampering with the entry process or operation of the Raffle or website or violates these Terms & Conditions. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Raffle may be a violation of criminal and civil laws. Should such attempt be made, Kids Quest reserves the right to seek damages and remedies available to the fullest extent permitted by law.



## RAFFLE RULES
