

## **Official Away We Go Vacation Giveaway Rules and Regulations**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

These are the official rules that govern the operation of the Away We Go Vacation Giveaway (the "Giveaway") taking place from April 1 – April 30, 2024. This Contest is sponsored by Kids Quest, Inc. (the "Sponsor") and is no way sponsored, endorsed or administered by, or associated with Facebook, Instagram, or Twitter. **Void where prohibited by law or where prior registration or approval is required, including, but not limited to, Puerto Rico and other US territories or possessions.**
