Official Dream Stay Giveaway Rules and Regulations

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

These are the official rules that govern the operation of the Dream Stay Giveaway (the “Giveaway”) taking place from May 1 – May 31, 2026. This Contest is sponsored by Kids Quest, Inc.
